Roger Strand: "RRI is a window of criticism, it is a dissident discourse"

On 8 June, Prof. Roger Strand gave a talk on the origin, definition and application of Responsible Research and Innovation (RRI) at [Universitat Pompeu Fabra](#) in Barcelona. To start the session, he exposed an obvious contradiction of RRI: on the one hand, it is vital at an institutional level and for new EU projects; but on the other hand, it is a rather unknown term among the scientific community and the general public. He also analyzed some of the sentences of its definition to prove that it is still quite an ambiguous term.
